

END USER LICENCE AGREEMENT

NOTICE TO ALL USERS: PLEASE CAREFULLY READ THE FOLLOWING LEGAL AGREEMENT

THE COPYRIGHT AND ANY OTHER INTELLECTUAL PROPERTY RIGHTS CONTAINED WITHIN THE SOFTWARE AND DATA THAT CONSTITUTE THIS SOFTWARE PRODUCT ARE AND REMAIN THE PROPERTY OF ABLETON ("ABLETON").

YOU - THE LICENSEE - ARE LICENSED TO USE THE SOFTWARE ONLY IF YOU ACCEPT ALL THE TERMS AND CONDITIONS SET OUT BELOW.

LICENCE ACCEPTANCE PROCEDURE: BY CLICKING THE ACCEPTANCE BUTTON THAT FOLLOWS THIS LICENCE AND/OR USING THE SOFTWARE, YOU INDICATE ACCEPTANCE OF THE LICENCE AND THE LIMITED WARRANTY AND LIMITATION OF LIABILITY SET OUT IN THE LICENCE. IF YOU ARE ACCEPTING THE LICENCE ON BEHALF OF A CORPORATE LICENSEE, YOU ARE SIGNIFYING THAT YOU ARE AUTHORISED TO DO SO. IF YOU ARE NOT SO AUTHORISED NOR DEEMED IN LAW TO HAVE SUCH AUTHORITY, YOU ASSUME SOLE PERSONAL LIABILITY FOR THE OBLIGATIONS SET OUT IN THIS LICENCE.

IF YOU DO NOT AGREE TO ALL OF THE TERMS OF THIS AGREEMENT, CLICK THE BUTTON THAT INDICATES THAT YOU DO NOT ACCEPT THE TERMS OF THIS AGREEMENT AND DO NOT INSTALL THE SOFTWARE. YOU SHOULD ALSO DESTROY ANY UNLICENCED COPIES THAT MIGHT BE IN YOUR POSSESSION.

1. **Definitions:** The term "Live" means Ableton Live and all sound samples, musical examples, included software instruments and effects, demo versions of other Ableton products supplied by Ableton herewith. The term "Live" shall also include any updates, upgrades or modified versions of Live licensed to Licensee by Ableton.

The term "Extension" means any add-on to Live whose serial number is supplied separately by Ableton to Licensee, and all updates and upgrades to the add-on.

The term "Software" means Live and all Extensions.

2. **Ownership rights:** The Software and related documentation are copyrighted works of authorship, and are also protected under applicable database laws. Ableton and its suppliers retain ownership of Software and all subsequent copies of Software, regardless of the form in which the copies may exist.

Ableton does not transfer any title to the intellectual property in the Software, and Licensee will not acquire any rights to the Software except as expressly set forth in this Agreement.

3. **Licence grant:** Provided that Licensee has paid the applicable licence fee, Ableton grants to Licensee a limited, non-exclusive licence to use and copy the Software for use on his computer system or file server for local execution over Licensee's network, owned, leased and/or controlled by Licensee or any member of Licensee's

corporate group, which expression includes a corporate licensee, such corporate Licensee's majority-owned subsidiaries, any parent company having a majority-owned interest in such corporate licensee, and such parent's majority-owned subsidiaries. Licensee may transfer the Software from one computer to another over Licensee's network but may not copy it to additional sites over the network or make additional copies for use on additional networks or sites. **Under this Licence the Software may only be used on one computer at a time.** Licensee may make backup copies of the Software.

Whenever a copy is made, it must be ensured that an Ableton copyright notice is attached, with an indication of all of Ableton's rights under the foregoing paragraphs in a machine-readable form (if machine-readable copies are being prepared) and/or in plain language. An indication of the ownership and all other rights of Ableton as defined in the foregoing paragraphs is to be attached clearly and visibly, printed on or firmly attached to all disks, diskettes or tape of any kind on which the licensed Software is stored. The Licensee is under an obligation to keep a record of all the copies he produces, and of their locations. He must present Ableton with this record at any time if there is any suspicion of misuse.

4. **Licence restrictions:** Licensee may not use, copy, modify or transfer the Software, or any copy in whole or in part, except as expressly provided for in this licence. Licensee may not reformat, mix, filter, re-synthesize or otherwise alter for use in any kind of commercial sampling product/package or software the sound samples and musical examples connected to the Software without the express written consent of Ableton. If Licensee transfers possession of any copy of the Software to another party except as provided above, this licence is automatically terminated. Licensee may not translate, reverse engineer, decompile, disassemble, modify or create derivative works based on the Software except as expressly permitted by this Agreement.
5. **No transfer:** Licensee may not rent, lease or sublicense the Software, on a temporary or permanent basis. Licensee may, however, transfer all his rights to use Live and/or any Extension as a whole to another person or entity, provided that Licensee uninstalls Live and/or any Extension from his computer, does not retain any backup copy of Live and/or any Extension and transfers this Agreement with Live and/or any Extension. **Versions of Ableton Live Lite, other OEM versions and Software that is or was labelled as NFR („Not for Resale“) may not be sold or transferred.**
6. **Demo Mode:** The purpose of the Demo Mode is, unless specifically mentioned, to facilitate the decision-making process with regards to acquiring a commercial version. **Any other use, in particular - but not limited to - resale, transfer, public use, is excluded.**
7. **Educational Versions:** Versions labelled "Educational Version" may be used only in an educational context by schools, teachers, instructors and students.
8. **Limited warranty:** Ableton warrants that the Software will substantially conform to the specification set out in accompanying documentation, minor interruptions or errors excluded. Ableton will only remedy deviations from the specifications providing that the deviation substantially affects Licensee's use of the Software.

Ableton may under such circumstances choose to replace Licensee's copy of the Software with a new one. The warranty period is twelve months from delivery unless compulsory provisions of applicable law determine otherwise. Ableton will also indemnify Licensee for personal injury or death solely and directly caused by any defect in its products or the negligence of its employees. **Ableton cannot be held responsible for the content and the origin of the data and samples that are obtained by the Licensee from a third party. Ableton is not accountable for modification or utilisation of these samples by the Software.**

9. **EXCLUSION OF LIABILITY: EXCEPT IN RESPECT OF PERSONAL INJURY OR DEATH CAUSED DIRECTLY BY THE NEGLIGENCE OF ABLETON, IN NO EVENT WILL ABLETON BE LIABLE TO LICENSEE FOR ANY DAMAGES, INCLUDING ANY LOST PROFITS, LOST SAVINGS, LOSS OF DATA OR ANY INDIRECT, SPECIAL, INCIDENTAL OR CONSEQUENTIAL DAMAGES ARISING OUT OF THE USE OF OR INABILITY TO USE SUCH SOFTWARE, EVEN IF ABLETON HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES.**
10. **Licensee's statutory rights:** This licence gives Licensee specific legal rights, and Licensee may also have other rights which vary from country to country. Some jurisdictions do not allow the exclusion of implied warranties, or certain kinds of limitations or exclusions of liability, so the above limitations and exclusions may not apply to Licensee. Other jurisdictions allow limitations and exclusions subject to certain conditions. In such a case the above limitations and exclusions shall apply to the fullest extent permitted by the laws of such applicable jurisdictions. If any part of the above limitations or exclusions is held to be void or unenforceable, such part shall be deemed to be deleted from this Agreement and the remainder of the limitation or exclusion shall continue in full force and effect. Any rights which Licensee may have as a consumer (i.e., a purchaser for private as opposed to business, academic or government use) are not affected.
11. **Term:** Licensee may terminate it at any time by destroying the Software together with all copies in any form. It will also terminate upon conditions set forth elsewhere in this Agreement or if Licensee fails to comply with any term or condition of this Agreement. Licensee agrees upon such termination to destroy the Software together with all copies in any form.
12. **General:** Each party hereby irrevocably agrees that this contract shall exclusively be subject to the laws of Germany. Place of jurisdiction shall be Berlin. Ableton can also, however, at its free discretion, open proceedings at the registered address of the licensee. The United Nations Convention on Contracts for the International Sale of Goods shall not apply to this Licence. This agreement constitutes the complete and exclusive statement of the agreement between Ableton and Licensee with respect to the subject matter hereof and supersedes all proposals, representations, understandings and prior agreements, whether oral or written, and all other communications between the parties relating thereto. All rights not explicitly granted in this agreement are reserved. Any clause in this agreement which is found to be invalid or unenforceable shall be deemed deleted and the remainder of this agreement shall not be affected thereby.
